FROM: BRIDGEPORT AREA, NEW YORK, NORTH TO EITHER:

MERRITT PARKWAY, EXIT 52, OR I-95, CONN. TURNPIKE, EXIT 27A

TAKE Rte 8, North, to Exit 19. End of exit (at light) take **LEFT** onto **WAKELEE AVENUE** ,
(Rte 334 WEST). Continue bearing **LEFT** , staying on **RTE 334 WEST, FOUNTAIN LAKE ROAD**,
(Shell Station on Right corner). PROCEED **1/3 MILE**; TAKE **LEFT** onto **BIRMINGHAM BLVD.;**
BUILDING 1/3 MILE ON LEFT.

FROM: HARTFORD AREA - VIA WATERBURY

Take **I-91 to (Rte 84 West, Waterbury) to Rte 8, South**, getting off at **Exit 19**. Take **LEFT** at end of exit, bearing to
FAR RIGHT at top of hill to **STOP SIGN (in front of Shell Station)**.

Take **RIGHT** onto **Rte 334 WEST (FOUNTAIN LAKE ROAD)**. PROCEED **1/3 mile**. Take **LEFT** onto
BIRMINGHAM BLVD.; **BUILDING 1/3 MILE ON LEFT.**

FROM: HARTFORD AREA - VIA WILBUR CROSS PARKWAY

Take **I-91, South**, to **Rte 15 (Exit 17) (Wilbur Cross Parkway) to Rte 34 (Exit 58)**.

Take **Rte 34 WEST**, continuing past **Orange-Derby Shopping Center (on right) , to the bridge intersection.**
(Rte 34 & 115 meet). Stay in the **CENTER LANE AS YOU ARE APPROACHING THE LIGHT AT THE BRIDGE**
INTERSECTION AND THEN BEARING TO THE RIGHT-HAND LANE AS YOU ENTER THE BRIDGE IN
PREPARATION OF TAKING THE NEXT RIGHT TO ROUTE 8, NORTH - WATERBURY.

TAKE Rte 8, North, to Exit 19. End of exit (at light) take **LEFT** onto **WAKELEE AVENUE** ,
(Rte 334 WEST). Continue bearing **LEFT** , staying on **RTE 334 WEST, FOUNTAIN LAKE ROAD**,
(Shell Station on Right corner). PROCEED **1/3 MILE**; TAKE **LEFT** onto **BIRMINGHAM BLVD.;**
BUILDING 1/3 MILE ON LEFT.

FROM: HARTFORD AREA - VIA I-95 TO NEW HAVEN TO ROUTE 34

I-95 SOUTH NEW HAVEN, EXIT 47 SOUTH, TO 34 WEST (downtown New Haven).

Get off at **Exit 3** (expressway ends). Stay straight on **North Frontage Road** which ends in a "T";

Take **RIGHT ONTO RTE. 10, bearing to Left Lane.** Take **LEFT** at next **Light** onto **ROUTE 34 WEST.**

Take **ROUTE 34 WEST** for the next **7.5 miles**, continuing past Orange-Derby Shopping Center (on right) **to the bridge intersection (7.5 mile point) where (ROUTE 34 & 115 converge), staying in the CENTER LANE AS YOU ARE APPROACHING THE LIGHT AT THE BRIDGE AND THEN BEARING TO THE RIGHT-HAND LANE AS YOU ENTER THE BRIDGE IN PREPARATION OF TAKING THE NEXT RIGHT TO ROUTE 8, NORTH - WATERBURY.**

TAKE Route 8, North to Exit 19. End of exit (at light) take **LEFT** onto **WAKELEE AVENUE , (RTE. 334 WEST), to light.** Take **LEFT** , staying on **ROUTE 334 WEST, FOUNTAIN LAKE ROAD, (Shell Station on Right corner).** **PROCEED 1/3 MILE; TAKE LEFT** onto **BIRMINGHAM BLVD.;** **BUILDING 1/3 MILE ON LEFT.**

FROM: DANBURY AREA - VIA ROUTE 8

Take Route 84 To Route 8 South, in Waterbury, or via Route 67 to Route 8 in Seymour, getting off at Exit 19.

Take I-91 to (Route 84 West, Waterbury) to Route 8, South, getting off at Exit 19.

Take **LEFT** at end of exit, bearing to **FAR RIGHT** at top of hill to **STOP SIGN (in front of Shell Station).**

Take **RIGHT** onto **ROUTE 334 WEST (FOUNTAIN LAKE ROAD).** **PROCEED 1/3 mile.** Take **LEFT** onto **BIRMINGHAM BLVD.;** **BUILDING 1/3 MILE ON LEFT.**

FROM: DANBURY AREA - VIA I-84, - OVER STEVENSON DAM

(Preferably for Cars not Large Trucks due to accent and decent of road.)

Take Exit 11, Route 34. At end of exit, take a **RIGHT.** Proceed to traffic light. Take a **RIGHT** onto **Route 34 East.**

Travel **9.9 miles** to the intersection of **Route 34 and Route 188 (Riverside Restaurant to right).** Take a **Left** onto

Route 188. Proceed **1.2 miles** to the junction of **Route 188 and Great Hill Road.** Take **Right** onto **Great Hill Road.**

Proceed **2.8 miles.** Take a **Right** onto **Birmingham Blvd.**
